Chiesa/De Martini unan. **6:40 p.m.** Conducted the public hearing; finds Lot Line Adjustment Application No. 2012-12 and Williamson Act Cancellation Application No. 2012-01, Berryhill Vineyards categorically exempt from the CEQA and ordered the filing of the Notice of Exemption; finds, based on the discussion in this report and the whole of the record: (A) that the cancellation is for land on which a

notice of nonrenewal has been served pursuant to Section 51245 of the California Government Code, (B) that cancellation is not likely to result in the removal of adjacent lands from agricultural uses, (C) that cancellation is for an alternative use which is consistent with the applicable provision of the city or county general plan, (D) that cancellation will not result in discontiguous patterns of urban development, (E) that there is no proximate non-contracted land which is both available and suitable for the use to which it is proposed the contracted land be put or, that development of the contracted land would provide more contiguous patterns of urban development than development of proximate non-contracted land, (F) that other public concerns substantially outweigh the objectives of the Williamson Act (Government Code Section 51200-51297.4); accepted the cancellation value of the subject property as \$90,000 as determined by the County Assessor; certified to the County Auditor the cancellation fee which must be paid as deferred taxes to be 12¹/₂% of the accepted cancellation value (\$11,250); approved the Tentative Cancellation of a portion of Williamson Act Contract No. 71-0062 subject to payment of the cancellation fee; unless the fee is paid within one year of the filing of the Certificate of Tentative Cancellation, the fee shall be re-computed as provided by State law; directed the Clerk of the Board to record a Certificate of Tentative Cancellation within 30 days of this action; directed the Clerk of the Board, within 30 days of the Board action, to publish the Notice of the Decision, pursuant to Government Code, and to deliver a copy of the published Notice of the Decision to the Director of Conservation; rescinded a portion of Williamson Act Contract No. 71-0062 and approve a new contract pursuant to Minor Lot Line Adjustment 2012-12 – Berryhill Vineyards; approved the Lot Line Adjustment Application No. 2012-12 - Berryhill Vineyards, subject to the completion of Williamson Act Contract Cancellation No. 2012-12; and, authorized the Planning and Community Development Director to execute a new contract pursuant to Minor Lot Line Adjustment 2012-12 and Williamson Act Contract Cancellation No. 2012-01 - Planning 2012-430

De Martini/Chiesa (2-2)(O'Brien and Monteith opposed)(Withrow abstained) **B8** The **motion failed** to approve Staff Recommendation No. 1(a) to terminate the Cost Reimbursement, Deposit and Forfeiture Agreement between West Park Holdings, LLC and Stanislaus County, dated 06/19/2012, based upon the failure to deposit the Escrow Funds on or before the 07/10/2012; terminate the relationship with the Master Developer – West Park Holdings, LLC; and, direct staff to return with strategic alternatives for proceeding with the development of the County-owned former Crows Landing Air Facility

B8 Supervisor Monteith made a **motion that failed for lack of a second** to extend the deadline to 08/23/2012 by 3:00 p.m. for West Park Holdings, LLC to deposit the Escrow Funds in the amount of \$2.75 million in full as detailed in the Cost Reimbursement, Deposit and Forfeiture Agreement dated

06/19/2012; to extend the deadline for the completion of the EIR to 04/30/2013; and, automatically terminate the agreement with West Park Holdings, LLC if the Escrow Funds are not received by the County Treasurer by the 08/23/12 deadline

B8 Chairman O'Brien **withdrew his motion** to approve Staff Recommendations Nos. 1a and 2 to terminate the Cost Reimbursement, Deposit and Forfeiture Agreement between West Park Holdings, LLC and Stanislaus County, dated 06/19/2012, based upon the failure to deposit the Escrow Funds on or before the 07/10/2012; terminate the relationship with the Master Developer – West Park Holdings, LLC and direct staff to return with strategic alternatives for proceeding with the development of the County-owned former Crows Landing Air Facility; direct the County Treasurer to promptly return to West Park Holdings, LLC all of the Escrow Funds on deposit with the County Treasury, less any bank fees and/or costs incurred by the County in returning the Escrow Funds, and any funds owed to the County by West Park Holdings, LLC for staff, consultant and legal fees as of 08/22/2012; and, add Staff Recommendation No. 3 to direct staff to issue an RFP as soon as possible for the development of the Crows Landing Naval Air Base with the same requirements that was placed on West Park Holdings, LLC including: fixing the infrastructure in Crows Landing, airport requirements, spec buildings that have to be built, no residential, \$2.75 million to be deposited with the County, have staff determine what the appropriate EIR period is, and have the same penalty for failure to complete the EIR within that time period as a forfeiture of any remaining funds and work product
