Mike Loza spoke regarding the labor negotiations with the County for IHSS Providers, and the needs of the IHSS clients.

Monteith/O'Brien unan. B7 Authorized the Project Manager to submit Schematic Design Drawings to the State of California, Board of State and Community Corrections, the State Fire Marshal and the California Department of Corrections and Rehabilitation for Project One (Housing and Medical/Mental Health); Project Two (Day Reporting Center) and Project Three (Intake Release, Transportation) as prepared by the HOK/LDA Design Team; as approved by Board of Supervisors Resolution, authorized the Project Manager to seek a possible project scope change from the Board of State and Community Corrections from two 192 maximum bed units to up to two 240 maximum bed units if within the Approved Project Budget and already allocated State funding; approved the Public Safety Center Expansion Site Development Study and Neighborhood Plan as prepared by HOK which recommends the exact location at the approved site, the Stanislaus County Public Safety Center for the Housing Project (Project One) and the Day Reporting Center (Project Two) and authorized the Project Manager to completed the required Real Estate Due Diligence with the State Agencies as required for AB 900 Phase II funding; authorized the Project Manager, in coordination with County Counsel, to negotiate, draft and execute the Board of State and Community Corrections Agreement and the Project Delivery and Construction Agreement between Stanislaus County and the State Public Works Board, the Department of Corrections and Rehabilitation, and the Board of State and Community Corrections for the Assembly Bill 900 (AB 900) Phase II Jail Financing Program for the construction of portions of the Stanislaus County Public Safety Center Expansion/Jail Construction Project; directed the Auditor Controller to increase appropriations and estimated revenue in the Jail Expansion Project budget in the amount of \$83,446,177 as detailed in the Budget Journal form to fully appropriate the approved Project Budget for all the remaining phases of work pursuant to the approved Project Plan; and, directed the Auditor Controller to increase appropriations and estimated revenue in the Project Three companion project budget in the amount of

Corr 2 Referred to the Alliance WorkNet and the Stanislaus Economic Development and Workforce Alliance, a letter from Silgan Containers Manufacturing Corporation regarding the temporary layoff of approximately 172 employees at their 3250 Patterson Road, Riverbank, CA facility beginning the week of October 20, 2013 and expects to recall employees in January 2014 per the Workers Adjustment and Retraining Notification (WARN Act) requirements.

Corr 3 Acknowledged receipt of claims and referred to the CEO-Risk Management Division the following claims: Evgeniy Viktorochich Gubanov; Anushik Ebeyan, and Ronald E Dafford.

Stan Risen, Interim CEO, reported that staff is closely watching SB 594(Hill) which would severely limit the ability of non-profits like our CSAC organization and the State Sheriff's Association to participate in State and local ballot campaigns. He gave an update regarding the Rim fire, and stated that our thoughts and prayers go out to those in Tuolumne County. He noted that significant resources have been sent from Stanislaus County, including 14 fire engines with over 51 fire personnel, as well as 20 law enforcement personnel from various agencies including our Sheriff's Department. FEMA has stepped in and has authorized the use of federal funds. The last report he received is that the fire is about 20 percent contained.

The Chairman announced that there will be a Public Dedication Ceremony for the Public Safety Center - Unit 2 New Jail Facility on Tuesday, 09/10/2013 at 4:00 p.m. located at the Stanislaus County Public Safety Center on 200 E. Hackett Road, Ceres, CA.
