**Corr 1** Referred to the Fish and Wildlife Committee, a Notice from the State Department of Fish and Wildlife regarding Proposed Rule Making for Lake and Streambed Alteration Agreements.

**Corr 2** Referred to the CEO and the Planning and Community Development Department, a letter from the Federal Aviation Administration (FAA) regarding upcoming meetings on the Environmental Assessment for the Northern California Optimization of Airspace and Procedures in the Metroplex Project.

Supervisor Withrow reported that he, Chairman Chiesa, and Assistant CEO Keith Boggs have started to meet with local employers to see how the County can assist in keeping businesses in our County.

Supervisor De Martini acknowledged Stanislaus County LAFCO for receiving an award from Cal-LAFCO for their agriculture mitigation policy. He noted that they also received the State’s most outstanding LAFCO award.

Chairman Chiesa gave an update regarding CSAC’s meeting with the Governor and Senate Pro Tem about their different plans to deal with the federal court order to decrease prison populations. He noted that they agreed to go with the Governor’s plan if they cannot get a stay order from the courts. He also reported that AB 1330 was amended and now would require the Air Resources Board, the local air districts, and the Department of Toxic Substances to double their fines for any operation that is found in violation within the Environmental Justice communities as defined by Cal-EPA (CalEnviroScreen). If CSAC does not fight this bill, he would like the Board to take a formal position on this matter.

Supervisor O’Brien spoke regarding EnviroScreen. He noted that the San Joaquin Valley Air Pollution Control District has concerns regarding this tool and the targeted enforcement in the Fresno area.

The CEO introduced and welcomed Pete Duenas, the new Senior Management Consultant in the CEO’s office.

The Interim CEO announced that there will be a Public Dedication Ceremony for the Public Safety Center - Unit 2 New Jail Facility on Tuesday, 09/10/2013 at 4:00 p.m. located at the Stanislaus County Public Safety Center on 200 E. Hackett Road, Ceres, CA.
