CEO Risen reported that water bond talks are taking place in Sacramento, and that Governor Brown is proposing \$2 billion in continuously appropriated funds for storage. It is anticipated that an agreement on a water bond will be wrapped up by this weekend. He also reported that this past week Chairman De Martini sent a letter of opposition to AB 2126, a bargaining labor bill which would expand mediation efforts based on a declaration of impasse. He noted that staff will continue to watch this bill closely.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
