Pledge of Allegiance to the Flag

Invocation was given by Reverend Condit of Village Chapel Church.

Reid Johnson invited the Board to the State Theatre on 7/30/2015, at 7:00 p.m., to view the film “Wait Till It’s Free,” a documentary on healthcare hosted by the Institute for Principle Studies. He said he would return with a healthcare proposal for the Board to consider at a future date.

Joan Rutschow spoke regarding the process of water desalination and the need to have this process implemented in California.

Carmen Sabatino voiced concerns regarding the proposed formation of the Downtown Modesto Community Benefit District and its associated ballot process. He noted that the ballots are weighted based on the property assessments and includes public buildings owned by the City of Modesto and the County within the proposed district. He stated that this gives the City 15% of the vote.

Raul Mendez, Hughson City Manager, spoke in support of Item \*C2 on today’s agenda regarding the Hatch Road Channelization Phase II Project, and he thanked the Board for their efforts in improving Hatch Road.

Emerson Drake spoke regarding the proposed Downtown Modesto Community Benefit District and voiced concerns that it will target the homeless population. Assistant Executive Officer Keith Boggs explained the ballot process and how the assessment funds will be used for beautification, security and marketing.

Sheriff Adam Christianson acknowledged the S.T.A.R.S. volunteers who have provided 9683.9 hours of support to the Sheriff Department and to the community. The Sheriff and the Board thanked the volunteers for their time and efforts to assist the community.

  - \*D1 Rescinded the entire Williamson Act Contract No. 2014-07, located at 648 S. Faith Home Road, between the Union Pacific Railroad and Clayton Road, in the Turlock area; pursuant to Government Code Section 51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract

would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years except as authorized under the County's implementation of AB1265; (b) there is no net decrease in the amount of the acreage restricted; in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the general plan; approved a new contract pursuant to Minor Lot Line Adjustment PLN2014-0079, Soderstrom; and, authorized the Director of Planning and Community Development to execute a new contract – Planning 2015-338

O'Brien/Monteith unan. **B11** Approved the second amendment to the agreement with Milhous Children's Services for the provision of intensive day treatment services for adolescents with serious emotional disorders through the end of FY 2014-2015; authorized the BHRS Director, or her designee, to sign the amendment with Milhous Children's Services to provide intensive day treatment services for adolescents with serious emotional disorders for the FY 2014-2015; and, directed the Auditor-Controller to increase appropriations by \$40,000 and to increase revenues by \$20,000 as outlined in the budget journal form – BHRS 2015-339

The CEO reported that the County will continue to watch AB 113 which includes the Negative Bailout fix. This bill did not come out of the Senate Budget Committee yesterday as hoped, and is being opposed by the League of California Cities due to redevelopment dissolution language.

Supervisor Chiesa noted that he just returned from the NACo Annual Conference in North Carolina, and stated that the southern states are dealing with similar issues as the State of California. He noted that the

new Vice President of NACo is from Texas, and that having leadership from the South provides a better representation for our County.
