Invocation was given by Pastor David A. Kerr with Trinity United Presbyterian Church.

Miguel Donoso spoke regarding the County's budget and the need for housing, employment, education and health for the Latino community.

John Mataka read a letter requesting that the County provide documentation regarding State and federal funding used for housing, employment, education and health to improve the lives of Latinos in the community. He requested that the Board form an Ad Hoc Committee to look into this matter. He also spoke in support of the Suicide Prevention/Intervention Innovation Project item on today's agenda.

Rebecca Harrington spoke regarding the conditions of the City of Modesto's Mancini Park, and the need for a community center in that neighborhood. She asked the Board for their support on this issue.

Katherine Borges from Salida spoke in support of the Focus on Prevention initiative on homelessness. She asked the County to continue supporting this important initiative.

Amanda Swanson from Salida also spoke in support of the Focus on Prevention initiative addressing homelessness. She expressed her appreciation that the Pelandale Avenue project is on track and that the overpass was opened early.

CEO Risen thanked Ms. Borges for her involvement and personal dedication to the Focus on Prevention initiative on homelessness. He stated that the County will continue to support the initiative on homelessness.
