Presentation regarding July 2016 as Park and Recreation Month was given, and the Chairman presented a resolution to Jami Aggers, Director of Parks and Recreation.

Katherine Borges spoke in support of Salida becoming an incorporated city.

Chiesa/O'Brien unan. Adopted the consent calendar after removing from consent item *C1 Approval to Summarily Vacate a Portion of the 20 Foot Alley in Block 3 of the Del Este Subdivision Located South of Yosemite Boulevard, East of Santa Rosa Avenue, North of Modesto and Empire Traction Railway, Lying South of the City of Modesto – PW

- *B2 Authorized the use of and transfer up to \$90,000 of Appropriations for Contingencies to the Board of Supervisors budget for the preparation of an economic analysis in response to the San Francisco Bay/Sacramento-San Joaquin Delta Estuary Phase 1 Draft Supplemental Environmental document; and, directed the Auditor-Controller to transfer \$90,000 in appropriations from the Appropriations for Contingencies budget to the Board of Supervisors budget as detailed in the Budget Journal form CEO 2016-358
- *B3 Accepted the second update on the state of the emergency remediation and repairs at the HSA Central Unit in accordance with the Public Contract Code Sections 20134 and 22050 to repair water damage and restore essential County operations CEO 2016-359

- *B4 Accepted the twelfth update on the Temporary Water Assistance Program in Stanislaus County; and, approved the continuation of the Countywide declaration of a local emergency due to a multi-year drought OES 2016-360
- *B5 Approved the Community Partner Playground Agreement, including the Letter of Intent, with KaBOOM! for the Fairview Park playground application; authorized the Director of Parks and Recreation, or designee, to sign the KaBOOM! Letter of Intent, the Community Partner Playground Agreement, and other documents that may be needed for the completion of the project, for the building of recreational play areas at Fairview Park; authorized the Director of Parks and Recreation, or designee, to negotiate and execute an agreement with Stanislaus County Police Activities League and Manos Unidas for the building of recreational play areas at Fairview Park, in substantial compliance with the draft MOU; and, authorized the Director of Parks and Recreation, or designee, to accept the donation from KaBOOM! for the value of the playground equipment and the donations from the community volunteers constructing the play areas at Fairview Park Parks and Recreation
- *B6 Authorized the Sheriff to submit a joint grant application to the Bureau of Justice Assistance and to accept the grant if awarded, for the 2016 Edward Byrne Memorial Justice Assistance Grant funding to enhance criminal justice processes; and, authorized the Chairman to sign the Memorandum of Agreement between the County of Stanislaus and the City of Modesto for the Justice Assistance Grant (JAG) Program Award Sheriff 2016-362

County Counsel determined that Supervisors O'Brien, DeMartini, and Withrow may have disqualifying conflicts of interest with item *C1 because of associations with E & J Gallo Winery. Therefore, in order to establish a quorum to consider this matter, the Board invoked the rule of necessity and drew lots to determine which Supervisor would participate in the decision. Supervisor O'Brien drew the long straw and thus participated in the decision.

Chiesa/O'Brien (3-0) (DeMartini and Withrow abstained) *C1 Pursuant to Street and Highway Codes Sections 8334 (a and b), 8335, and 8340: finds based on the reasons stated in the agenda item, this portion of alley as described in Exhibits "A" and "B", is not required for street and highway purposes; finds all public utility easements will be retained for the benefit of in-place public utility facilities; and, adopted the resolution vacating the portion of alley lying within Block 3 of the Del Este Subdivision located south of Yosemite Boulevard, east of Santa Rosa Avenue, north of the Modesto and Empire Traction Railway (M&ET Railway), and lying south of the City of Modesto as described in Exhibits "A" and "B", attached to the agenda item – PW
