Unanimous consent must be received from properties on the same street and within 150-feet of a speed hump location in a 15 mph zone and; within 250-feet of a speed hump location in a 25 mph zone; and within 350-feet in a 35 mph zone."; and, authorized the Director of Public Works to make program modifications under the authority as Road Commissioner – PW
