Supervisor DeMartini reported the Westside Healthcare Task Force has completed judging the recent Art Contest and the winners will be featured in a calendar.

Supervisor Chiesa encouraged everyone to attend the upcoming State Water Resources Control Board public meetings on: 12/16/2016 at the Stockton Memorial Civic Auditorium, 12/19/2016 at the Merced Theatre, and 12/20/2016 at the Modesto Center Plaza. There will be an opportunity to provide comments to the draft revised Substitute Environmental Document on the proposed updates to the Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (Bay-Delta Plan). He noted this issue is very important for our long-term economic well-being.

CEO Risen reported that two weeks ago, he attended the CSAC Annual Conference along with Supervisors Chiesa and DeMartini. He gave an update regarding the State Legislature which went back into session on 12/05/2016 for the 2017-2018 Legislative Session. At the federal level, Congress passed a spending bill that will keep the government running until 04/28/2017. Congress also passed a \$12 billion water bill that should bring more water flow into our drought stricken valley. CEO Risen noted his appreciation for the support from Representative Kevin McCarthy and Senator Dianne Feinstein on this bill.

Chairman Monteith reported that the State Legislature has increased the maximum number of bills legislators can introduce from 40 to 50 bills each year.
