Emerson Drake spoke regarding various concerns including the Sheriff's helicopter, jail medical contract, a donated vehicle to the DA's office, and evidence tracking.

Officer Tom Olsen, the new CHP Public Information Officer, spoke regarding the vehicle sideshows that happened last weekend.

Jim Gonzales, retired San Francisco County Supervisor, commended the Board of Supervisors for their commitment to youth and future generations.

- *B2 Accepted the twentieth update on the Temporary Water Assistance Program in Stanislaus County; approved the continuance of the Countywide declaration of a local emergency due to a multi-year water shortage; directed staff to close the Temporary Water Assistance Program application period and grant no continued lease agreements with current program participants effective upon Board approval of this item; and, directed staff to continue working with those individuals who are currently receiving assistance to find a permanent water supply solution – OES 2017-52
- ***B3** Approved the CEO-OES to apply for funds available through the FY 2017 Homeland Security Grant Program OES 2017-53
- *B4 Approved the appointment of the top candidate to the position of Manager III as the Human Resources Manager with the Health Services Agency at an annual salary of \$97,801.60 which is above the mid-point of the salary band – HSA 2017-54
- *B5 Accepted the fourteenth update on the state of the emergency remediation and repairs at HSA Central Unit, in accordance with Public Contract Code Sections 20134 and 22050, to repair water damage and restore essential County operations – CEO 2017-55
- *B6 Approved a request from CEO-Risk Management to fund a Comprehensive Roadway Safety Analysis to improve community safety and reduce organizational liability; approved the use of up to \$500,000 in Appropriations for Contingencies as the local match for the Highway Safety Improvement Program Grant administered through Public Works; and, authorized the CEO and Auditor-Controller to make the necessary adjustments as detailed in the Budget Journal attached to the agenda item – Risk Management 2017-56
- *B7 Approved the amendment to the agreement between the County of Stanislaus and California Forensic Medical Group, Inc. for inmate health services; authorized the Chairman to sign the amendment; authorized the Auditor-Controller to transfer appropriations from the Appropriations for Contingencies budget to the CEO-Jail Medical Program budget per the Budget Journal, attached to the agenda item; and, authorized the CEO to enter into an agreement with the Department Health Care Services to participate in the Medi-Cal County Inmate Program for FY's 2016-2017 – 2017-2018 – CEO 2017-57
