Olsen/Monteith unan. 9:10 a.m. Conducted a public hearing to consider Planning Commission's recommendation for approval of Rezone Application No. PLN2017-0062, Masellis Enterprises, LLC, located at 118 Albers Road, on the northeast corner of Albers Road and Yosemite Boulevard, east of the City of Modesto; adopted the Negative Declaration pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Negative Declaration reflects Stanislaus County's independent judgement and analysis; ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder pursuant to Public Resources Code Section 21152 and CEQA Guidelines Section 15075; finds that (a) the project is consistent with the overall goals and policies of the County General Plan; (b) the proposed Planned Development zoning is consistent with the Agriculture General Plan designation; (c) the alternative to the Agricultural Buffer Standards applied to this project provides equal or greater protection than the existing buffer standards; (d) the project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements; approved Rezone Application No. PLN2017-0062 – Masellis Enterprises, LLC, subject to the Development Standards and Development Schedule, attached to the agenda item; and, introduced and waived the reading, and adopted Ordinance C.S. 1208 for the approved Rezone Application No. PLN2017-0062 – Masellis Enterprises, LLC – Planning 2017-699 & 2017-700 ORD-56-B-5

Olsen/Wthrow unan. 9:15 a.m. Conducted a public hearing to consider an appeal of the Planning Commission's denial of Variance Application No. PLN2017-0064 – Hickman Market, located at 13135 Lake Road, east of Hickman Road, northwest of Montpelier Road, in the Hickman area; finds that there is no substantial evidence the project will have a significant effect on the environment and that the Exemption reflects Stanislaus County's independent judgment and analysis; finds the project is generally exempt from the CEOA pursuant to Section 15035 and ordered the filing of a Notice of Exemption; finds (a) that because of special circumstances applicable to the subject property, including size, shape, topography, location or surroundings, the strict application of this title will deprive the subject property of privileges enjoyed by other properties in the vicinity and under identical zone classifications; (b) that the granting of the application is necessary for the preservation and enjoyment of substantial property rights of the petitioner and will not constitute a grant of special privilege inconsistent with the limitations upon other properties in the vicinity and zone in which the subject property is situated; (c) that the granting of the application will not, under the circumstances of the particular case, materially affect adversely the health or safety of persons residing or working in the neighborhood of the property of the applicant and will not, under the circumstances of the particular case, be materially detrimental to the public welfare or injurious to property or improvements in the neighborhood; approved the appeal of the Planning Commission's denial of Variance Application No. PLN2017-0064 - Hickman Market; amended Condition of Approval No. 10 to read as follows: "The construction of an 8-foot high masonry wall along the portion of the eastern property line adjoining the parcel under the same ownership as the project site shall be deferred until title to the project site or the adjoining parcel to the east (both owned by the applicants) is changed through sale or transfer."; and; approved the variance application subject to the Conditions of Approval as amended – Planning 2017-701
