- **5.D.1** Rescinded all of Williamson Act Contract No. 1972-0966 and a portion of contract No. 1974-1563, located at 2627 Bancroft Road, between Paradise Road and the Tuolumne River, west of the City of Modesto, APN's: 017-027-017 and 048; finds that pursuant to Government Code Section 51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract, or contracts, would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contract, or contracts, but for not less than ten years, except as authorized under the County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted, in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract, or contracts, remains under new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved new contracts, pursuant to Lot Line Adjustment Application No. PLN2018-0083, Ott-Dickerson; and, authorized the Director of Planning and Community Development to execute new contracts – Planning

Withrow/Olsen unan. 7.2 Accepted the 10th Street Place JPA authorization to take all actions and issue all contracts on behalf of or for the benefit of the 10<sup>th</sup> Street Place JPA that are necessary or expedient to remediate, restore, and recover the damaged facilities at the City-County Government Center at 10<sup>th</sup> Street Place; declared an emergency in accordance with Public Contract Code Section 22050 for emergency repairs needed at 10<sup>th</sup> Street Place due to damage caused by water intrusion due to weather that has occurred since the building was opened; approved actions in accordance with Public Contract Code Sections 20134 and 22050 in order to make the immediate repairs required at 10<sup>th</sup> Street Place; made the following findings: (a) that the damages occurred at 10<sup>th</sup> Street Place as a result of a water leak caused by inclement weather over time; (b) that immediate repairs are necessary to permit the continued activities of essential operations or services; (c) that the emergency will not allow for a delay that would result if the project were competitively bid, and that the action to immediately repair the building on an emergency basis is necessary; directed the Chief Operations Officer to serve as Project Manager for all aspects of this project; authorized the Project Manager to negotiate and execute an agreement with Solid Solutions, Construction Services Inc., of Modesto, California and other contractors as necessary to complete the emergency abatement, demolition and clean-up of the site; authorized the Project Manager to order any action appropriate to repair the water damage and restore the affected areas, and to take any directlyrelated immediate action required by that emergency, and to procure the necessary equipment, services and supplies for those purposes, without giving notice for bids to let a contract; and, required the CEO to report to the Board on the status of the emergency project at its next regularly scheduled meeting and every 14 days thereafter, as required by the Public Contract Code until the repairs are completed – CEO 2018-0514

He noted that the "Dirty Bird Music Festival" was held at the Modesto Reservoir this past weekend and the Parks and Recreation Department did an outstanding job. 7,500-people attended this event with very little incident.

CEO Hayes commended the Parks and Recreation Department for the "Dirty Bird Music Festival" and acknowledged how well organized the event was.
