Chairwoman Olsen presented a resolution to Carmen Morad in recognition of the Assyrian Wellness Collaborative.

Astrid Zuniga spoke in support of a pay increase for In-Home Supportive Services (IHSS) providers.

Melinda Kirkland voiced support for increased wages for IHSS providers.

Terry Walker spoke in support of wage increases for IHSS providers.

Prior to consideration of the consent calendar, CEO Hayes announced, in accordance with Government Code Section 54953(c)(3), that agenda item **5.B.8** would approve the appointment of Mark Ferriera to serve as the Chief Probation Officer at a starting salary of \$152,006.40, plus Department Head benefits as set forth in the agenda item.

Chiesa/Withrow (4-0) (Berryhill absent) **5.B.3** Authorized the Chief Executive Officer to sign a letter of consent for initial refugee resettlement in Stanislaus County as per the terms of Executive Order 13888 – CSA 2020-0016

Withrow/DeMartini (4-0) (Berryhill absent) **5.B.4** Authorized the CSA Director, or her designee, to apply for, and if awarded, enter into and sign the agreement(s) for the California Homelessness Coordinating and Financing Council Homeless Housing, Assistance and Prevention Program (HHAP) Competitive Allocation Funding to support regional coordination to address immediate homelessness challenges; affirmed the Community System of Care (CSOC) designation of Stanislaus CSA as the Administrative Entity (AE) for the County to accept and administer HHAP funds; authorized the CSA Director, or her designee, to apply for, sign for, and accept funds in an amount to not exceed \$4,378,625, including the submission of all documents required to secure funding from the HHAP; authorized the CSA Director, or her designee, to release RFP's related to HHAP services and to negotiate and execute HHAP service agreements; and, directed the Stanislaus County Auditor-Controller to increase appropriations and revenues by \$4,378,625 from the HHAP program upon award and receipt of the funding in the CSA Housing and Homeless Services Fund 1639, per the budget journal attached to the agenda item, and pursuant to the HHAP grant allocations dated 01/03/2020 - CSA

Chairwoman Olsen acknowledged a representative from Assemblymember Adam Gray's Office.

CEO Hayes reported the release of the Governor's January Proposed Budget which includes funding for homelessness. The Governor also proposes to expand a pilot program allowing Caltrans to lease unused State property for emergency shelters. The County will work with the Stanislaus Homeless Alliance regarding this pilot program.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
