- 4.B.1 Approved Amendment No. 4 to the agreement for Independent Contractor Services with Holt of CA, for heavy equipment repair and maintenance at the Fink Road Landfill, which extends the term of the contract two additional fiscal years through FY 21-22, and increases the contract by \$764,526, for a not to exceed amount of \$1,754,526; authorized the Director of DER, or designee, to execute Amendment No. 4 with Holt of CA; and, authorized the Director of DER, or designee, to sign amendments to the agreement for an overall total not-to-exceed amount of \$1,830,979, which includes a contingency of \$76,453 DER
