Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

Ceres Main Canal, in the Waterford area, APNs: 019-005-005, 019-005-006, and 019-003-002; finds pursuant to Government Code Section 51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract, or contracts, would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contract, or contracts, but for not less than ten years, except as authorized under the County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract, or contracts remains under the new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved a new contract(s), pursuant to Lot Line Adjustment Application No. PLN2018-0170, Short Ranch Partnership; and, authorized the Director of Planning and Community Development to execute a new contract, pursuant to Lot Line Adjustment Application No. PLN2018-0170, Short Ranch Partnership – Planning 2020-0118

Withrow/DeMartini unan. **8.2** Authorized the District Attorney to accept a grant award from the California Governor's Office of Emergency Services Victim/Witness Assistance Program for Federal FY 2019-2020 in the amount of \$1,037,225; authorized the District Attorney to sign the grant award agreement, including any extensions or amendments; amended the Salary and Position Allocation resolution to reflect the staffing changes described under the Staffing Impacts section effective the first pay period following the Board of Supervisors' approval; and, authorized the Auditor-Controller to increase estimated revenue and appropriations in accordance with the Budget Journal attached to the agenda item – District Attorney 2020-0120

Chiesa/DeMartini unan. 8.3 Approved the Schematic Design for the HSA Administration/Public Health Facility Project, as presented by the Bridging Architect, and authorized proceeding to the Bridging Design phase of the project; approved the recommended changes to original funding plan that was adopted by the Board on 03/05/2019, for the project which includes a reduced project cost; a smaller footprint for the project; a reduced use of Securitized Tobacco Tax funds and an increase of repayment for the administrative portion of the proposed project; designated the CEO, or his designee to act as Project Manager for the HSA Administration/Public Health Facility Project; directed the project team to explore the feasibility of the possible inclusion of the Mountain Valley Emergency Medical Services Agency into the project, returning to the Board with future recommendations; approved a Professional Services Agreement in the amount of \$598,840 with Kitchell CEM Management Inc., with offices in Fresno, CA to provide Construction Management Services for the HSA/Public Health Facility Project; and authorized the execution of the Professional Services Agreement and to negotiate and execute amendments to these agreements for additional services, if needed, so long as appropriations are available within the project budget; approved a Professional Services Purchase Order Agreement in the amount of \$183,747, with Gensler Inc. to provide Real Estate Assessment and Strategic Planning Services for County Center II, located at 830 Scenic Drive, Modesto, to be funded by existing appropriations in the FY 2019-2020 CEO-Plant Acquisition budget; and, authorized the Project Manager to sign contracts and work authorizations for professional services needed for this phase of the project, so long as they are within the project budget - CEO 2020-0121

Supervisor DeMartini noted that he was on the Election Observer Panel for the election Tuesday, 03/03/2020. He stated that the election went smoothly.

Chairwoman Olsen announced that she, along with the Sheriff, CEO, Assistant Director of Emergency Services and the Managing Director of HSA, will stream a Facebook Live session on Wednesday, 03/18/2020, at 5:00 p.m. regarding the local public health emergency due to COVID-19 (Coronavirus). She mentioned that if seniors need help with groceries or other services to contact their local church or call 211 for assistance.

CEO Hayes reported that he asked County Departments to evaluate essential vs. non-essential services to determine where we can deploy maximum social distancing between employees and the public to keep everyone safe. This evaluation will also identify which employees can be diverted into essential services if needed. He reported that the website www.loveourneighbors.org will be heavily relied upon to support our community throughout this effort.
