Berryhill/Chiesa unan. **5.1** Conducted a public hearing to consider the Planning Commission's recommendation of approval of Rezone Application No. PLN2019-0093, Tenaya Banquet Hall, a request to amend the zoning designation of a 2.91-acre parcel from Industrial (M) to Planned Development (P-D) to establish a catering and event venue, with two separate event spaces, in an existing 34,720 square-foot commercial building, located at 2206 Tenaya Drive, on the southeast corner of Mitchell Road and Tenaya Drive, in the Modesto area; adopted the Negative Declaration pursuant to CEQA Guidelines Section 15074(b), by finding that, on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Negative Declaration reflects Stanislaus County's independent judgment and analysis;

ordered the filing of a Notice of Determination with the Stanislaus County Clerk Recorder's Office pursuant to Public Resources Code Section 21152 and CEQA Guidelines Section 15075; finds, based on the discussion in the report, and the whole of the record that: (a) the project is consistent with the overall goals and policies of the County General Plan; (b) the proposed Planned Development zoning is consistent with the Industrial General Plan designation; approved Rezone Application No. PLN2019-0093, Tenaya Banquet Hall, subject to the Development Standards attached to the 04/16/2020 Planning Commission Staff Report, attached to the agenda item; and, introduced, waived the reading, and adopted Ordinance C.S. 1273 for the approved rezone – Planning
