Invocation was given by Marvin Jacobo from the City Ministry Network.

Judy Kindle, CEO for Sierra Vista and Family Services, was recognized upon her retirement with a commendation.

Chairwoman Olsen acknowledged receipt of written public comments. She noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Gina Aaron from In-Shape Health Clubs spoke in support of gyms staying open even if our tier changes to purple.

Miguel Donoso asked about the power of the CEO and his ability to reorganize the Continuum of Care (COC). He spoke regarding the annual Point-In-Time Count and suggested that there be a component for racial and ethnic equity to coordinate work in this area. He recommended that we include individuals who are homeless to help with the Point-In-Time Count. He asked whether the County owns or rents the hotel on 9th Street in Modesto that is being used as a family shelter.

Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Supervisor Chiesa reported that Donna Linder, Registrar of Voters, will provide an update on the Election results later this afternoon.

Supervisor DeMartini served on the Election Observer Panel for the 11/03/2020 election and did not see anything to be concerned about. He voiced concerns regarding all mail elections and spoke regarding ballot harvesting. He recommended that ballots in the future include a note to voters to use blue or black ink, that the candidate names be capitalized, and that Elections clean up voter rolls to avoid duplicate ballots. He also spoke regarding the 10/12/2004 Development Agreement with the City of Patterson, and voiced concerns that the City will consider rezoning this area at their 11/17/2020 Council meeting.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
