March 30, 2021

Invocation was given by Reverend Scott Miller from Big Valley Grace Church.

Joe Wayne Mendoza from the Sheriff's Department and Robert J. Taro from County Counsel received their 25-year Employee Service Award. Robert D. Van Trease from the Sheriff's Department and Ramona Brown from HSA received their 30-year Employee Service Award.

Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Miguel Donoso shared concerns regarding the mental health effects of COVID-19 and inquired about deaths in July sorted by ethnicity. He also spoke about problems with housing and inquired about the programs and policies that are being worked on to improve this crisis.

Deborah Harper thanked the Board for their COVID-19 efforts. She shared concerns regarding COVID-19 social distancing efforts and asked about the vaccination clinic at the Modesto Centre Plaza. She stated she was suspended from the bus system.

Michael Crowell voiced concerns regarding the mental health effects on children in Stanislaus County due to the COVID-19 impacts to education and requested the Board help balance education and the virus.

Pam Franco, Vice Mayor of Turlock, spoke about the homeless emergency in the City of Turlock and requested any assistance the County can provide. She also requested the County look at improvements that can be made to roads and landscaping at the points of entry to the City of Turlock. She shared her experience at the COVID-19 vaccination clinic at Stanislaus State and suggested the County look for improvements to speed up the process and experience of receiving your vaccination in the non-appointment line.

The CEO also introduced Kamal Bagri as the new Agricultural Commissioner and Sealer of Weights and Measures. Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
