CEO Hayes reported that Governor Newsom signed AB37 which requires the County Elections Official to move to a vote by mail ballot process for all registered voters. He noted that voters can still vote at a

specific voting center if they prefer. This bill permanently extends the deadline from 3 to 7 days for Elections to receive a timely ballot if voted on or before election day. He reported that staff will be meeting with the federal Economic Administration later this week about our request for grant funding to support water infrastructure at the Crows Landing Industrial site.

Supervisor B. Condit asked for information regarding SB9 and SB10. County Counsel Boze responded that these bills are regarding affordable housing and that he will provide additional information to the Board members on this topic.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
