Invocation was given by Pastor Jeffrey Woods with First Christian Church.

Adriana Taylor and Ricky Bispo from Stanislaus County Office of Education presented Red Ribbon Week Photo and Poster contest winners.

CEO Hayes, Sheriff Dirkse, Public Health Officer Dr. Vaishampayan, and Director of the Health Services Agency Mary Ann Lily-Tengowski provided an update of the 2019 Novel Coronavirus (COVID-19) Emergency and Essential Services in Stanislaus County.

Chairman Chiesa acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Steven Morrow noted that 80 years ago Pearl Harbor was attacked and remembered those who served during World War II.

Emerson Drake spoke regarding the Library system and shared how the Library can make a difference in children's lives.

Dr. Amrik S. Basi, with Elite Urgent Care, spoke regarding monoclonal antibodies. He shared that Elite Urgent Care offers these antibodies. He asked why more providers aren't giving monoclonal antibodies.

Keryn Whitlow shared concerns regarding the lack of doctors aware of monoclonal antibody therapy.
