Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

December 14, 2021

Invocation was given by Pastor Lance Lowell with Neighborhood Church.

Donna Linder, Clerk-Recorder and Registrar of Voters, announced that her office is holding Voter Workshops starting in January in various locations throughout the County.

Steven Morrow acknowledged the work done by the Stanislaus County Ad Hoc Citizen Redistricting Commission. He spoke regarding the importance of voting and the need to encourage members of the community to register to vote.

Jordan Hertwig, a nurse, shared that she has been placed on unpaid administrative leave by a local hospital for failure to comply with the COVID-19 vaccine mandate. She spoke regarding her experience in applying a medical waiver and a religious waiver which were both ultimately denied. She noted the importance of health care workers and voiced concerns about nursing shortages, the lack of autonomy of physicians, and the erosion of individuality of patient care. She spoke in support of offering vaccine alternatives.

Margaret Countryman noted that she spoke with Congressman Harder and his staff regarding her appeal of the City of Modesto's Board of Zoning Adjustment decision concerning a neighbors second story on a garage. She noted that she has contacted attorneys and plans to contact the State Bar Association regarding this case.

Chairman Chiesa acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

CEO Hayes congratulated Raul Mendez upon being selected as the new CEO for Merced County. He reported that the 8 Central Valley counties are working on a letter to the Governor requesting support for various needs including economic development and water resources. The CEO noted that the Board of Supervisors adopted a new Supervisorial District Map at the 12/13/2021 special board meeting, which adjusts the boundaries of the Stanislaus County Supervisor Districts. CEO Hayes also reported that the California Department of Public Health issued a new masking order that will go into effect 12/15/2021 through 1/15/2022.
