He shared this past weekend he attended the Annual Cherokee Nation At-Large Pow Wow in Suisun City.

Representative Gavin Cline from Congressman Duarte's Office provided an update on the activities happening in the 13th Congressional District.

Representative Justin Farkas from Assemblymember Juan Alanis' Office provided an update on the activities happening in the 22^{nd} Assembly District.

CEO Hayes announced in accordance with Government Code Section 54953(c)(3), the appointment of Eric McLoughlin to serve as the Stanislaus County Chief Information Officer/Information Technology Center (ITC) Director at a starting salary of \$169,000 annually, plus Department Head benefits.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
