Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

January 30, 2024

Invocation was given by Mike Gunnarson with City Ministry Network.

Supervisors C. Condit and B. Condit presented the Cherokee Nation Principal Chief Chuck Hoskin, Jr. and Cherokee National Treasurer Tommy Wildcat with commendations.

Sheriff Dirkse and Lt. Tim Burns provided an update on the Stanislaus County Sheriff's Office Inmate Program.

John X. Mataka, President of Grayson Neighborhood Council, Community Advocate for Valley Improvement Projects, and member of the Stanislaus County Local Task Force (LTF) on Solid Waste Management voiced concerns regarding the lack of quorum at the LTF meetings, and that a County attorney attended the last LTF meeting without identifying herself. He asked for two items on the LTF agenda: the purpose of the LTF and a presentation on zero waste. He noted that Covanta sent a notice to Stanislaus County and the City of Modesto that they are losing money and want to increase tipping fees and burn more special waste, or terminate the contract. He asked for a public hearing on these options so that the public can weigh in.

Steven Morrow voiced concerns regarding AT&T's letter to the CA Public Utilities Commission requesting approval to not being a provider of landline service any longer in CA. He also shared concerns regarding SB 961 which would require speed-limiting devices on all vehicles starting 2027. He asked the Board to look into these items and requested a presentation at a future Board meeting regarding these topics.

Laura Plascencia, Community Organizer with Valley Improvement Projects, suggested that the County adopt zero waste practices within the goals and budgeting priorities for the year, have more open collaboration with community organizations, and a more in depth look at the contract with Covanta to ensure they clean up any residual pollution. She shared that Valley Improvement Projects contracted with Zero Waste USA to develop a Zero Waste Plan. She shared that members of the community are ready to start engaging in zero waste.

Bianca Lopez, Co-Founder of Valley Improvement Projects, noted that she was pleased that Covanta announced that it is no longer economically viable to burn trash in Stanislaus County and Long Beach. She noted that last Saturday, over 100 people viewed "Burning Injustice" a documentary made by The Story of Stuff Project. After the film, they looked at the Zero Waste Plan and announced that Covanta is closing. She suggested that the LTF on Solid Waste be reassigned to a zero waste task force and to involve the community.

Supervisor Withrow congratulated Keryn Whitlow for being named Nurse of the Year.

Chairman Grewal acknowledged the Mayor of Patterson, Michael Clauzel who attended today's Board meeting.
