a. Updates on Economic Development Projects and Initiatives

The City of Modesto provided updates on multiple city projects, notably highlighting a \$12.2 million grant from the Federal Railroad for the enhancement of 22 railroad crossings across the city, aimed at improving public safety. This grant will also facilitate the upgrade of two locomotive diesel engines to mitigate environmental impacts.
