**NOTICE OF PUBLIC HEARING FOR A PROPOSED 46-LOT SINGLE-FAMILY SUBDIVISION, PROJECT  
LOCATED ON CHANDON DRIVE NORTH OF MONTORRA DRIVE**

**(REVISED NOTICE TO CORRECT DATE OF PUBLIC HEARING  
FROM SEPTEMBER 14, 2019 TO SEPTEMBER 14, 2020)**

A public hearing will be held by the **Planning Commission** of the City of Modesto at **6:00 pm on September 14, 2020**, via livestream through a link on [www.modestogov.com](http://www.modestogov.com), regarding the application of NRB Investments LLC for proposed amendments to the Village One Specific Plan and Precise Plan Area No. 20 Subarea C, to allow small-lot single-family developments at a minimum density of 10 units per net acre in the Senior Housing land use designation, together with a Final Development Plan and Vesting Tentative Subdivision Map to divide 5.35 acres located on Chandon Drive north of Montorra Drive into 46 small-lot single-family residential lots and two landscape lots. This notice is to correct a previous notice posted with the incorrect hearing date. This project is within the scope of the Modesto General Plan Master EIR (State Clearinghouse No. 2014042081) and the Village One Specific Plan Program EIR, approved earlier, and the Master EIR adequately describes the activity for the purposes of CEQA. The meeting will be held in chambers, 1010 Tenth Street, Modesto, California, but may not be physically open to the public. In order to minimize the spread of the COVID-19 virus, this meeting will be conducted pursuant to the provisions of the Governor's Executive Orders N-29-20, which suspended certain requirements of the Brown Act and will not be physically open to the public.
