NOTICE OF EXEMPTION

Project Title: <u>Westley Property LLC. Water System (5000577)</u>

Description of Project: The project involves permitting a replacement water well for an existing Transient, Non-Community water system at the Westley Properties LLC site serving an existing Motel 6 and a proposed Arco Gas Station/Convenience Store/Subway Sandwich shop in Westley, CA. The existing well was drilled decades ago and, based on downhole video observation, its structural stability and well seal are failing. The existing well will be properly abandoned and destroyed. The replacement well will be located approximately 10 feet from the existing well. The new well will be completed in the same aquifer as the existing well at a completion depth of approximately 400 feet. The additional volume of water estimated to be used to serve the proposed expansion (there is no change in the water demand for the Motel 6) is about 4.5 acre-feet per year or 4,000 gallons per day (less than 3 gallons per minute on an average daily basis). The increase in water demand associated with the proposed expansion is not considered to be significant pursuant to CEQA guidelines.
