Description of Nature. Purpose and Beneficiaries of Project: The proposed project consists of construction of 18 additional 3-inch monitoring wells at locations Cities of Modesto, Riverbank, Oakdale, Waterford, and Stanislaus County. Each well will be installed in an 8-inch borehole with total depth varying between approximately 50 to 400 feet. The purpose of this project is to supplement the groundwater monitoring network established to collect static water level data and in-situ water quality information to better understand and manage groundwater use to ultimately achieve sustainable groundwater pumping. The City of Modesto is the Lead Agency undertaking this project on behalf of the Stanislaus and Tuolumne River Groundwater Basin Association Groundwater Sustainability Agency (STRGBA GSA).
