

FICTITIOUS BUSINESS NAME STATEMENT INFORMATION BUSINESS AND PROFESSIONS CODE SECTION 17900-17930

The filing of a fictitious business name certificate is designed to make available to the public the identities of persons doing business under the fictitious name (B&P §17900 (a) (1)).

WHO SHOULD FILE?

- Persons doing business for profit under a fictitious name (B&P §17910) (does not include surname in company name)
- The statement must be filed in county of principal place of business and may also be filed in other counties as long as the requirements for filing in the county of principal place of business have been met (B&P §17915); and
- Non-profit corporations, organizations or associations are not required to file a Fictitious Business Name Statement (B&P §17911)

PUBLICATION REQUIREMENTS

- Within 30 days after filing a fictitious business name statement, the registrant must publish the statement in a newspaper of general
 circulation in the county of its principal place of business (B&P §17917 (a));
- The notice must appear once a week for four (4) successive weeks (GC §6064); and
- Within 30 days of the last publishing date, the registrant must file an affidavit of publication with the County Clerk's office (B&P §17917(d)).

NEWSPAPERS

- Individuals are encouraged to check with the newspaper first to determine the preferred method of publishing
- Some newspapers do not take walk in customers
- Individuals can often electronically submit their paperwork
- Individuals publishing the Fictitious Business Name Statements are not required to physically go to a newspaper office

NEWSPAPERS

BUSINESS AND PROFESSIONS CODE SECTION 17918 PROVIDES:

"No person transacting business under a fictitious business name contrary to the provisions of this chapter, or his assignee, may maintain any action upon or on account of any contract made, or transaction had, in the fictitious business name in any court of this state until the fictitious business name statement has been executed, filed, and published as required by this chapter. For the purposes of this section, the failure to comply with subdivision (b) of Section 17917 does not constitute transacting business contrary to the provisions of this chapter." BUSINESS LICENSES

This office does *not* issue business licenses. Business licenses are permits issued by government agencies that allow individuals or companies to conduct business within the government's geographical jurisdiction.
