*Program **NOT** available to commercial or box/bin customers



Large Items Ready for Bulky Item Pick Up

- Pick-up is by appointment only and allowed two times per year
- Call your garbage hauler at least two weeks ahead to schedule pick-up (Numbers listed below)
- Set items at edge of County or State maintained road AFTER 6:00 p.m. the day before scheduled appointment
- Items set out for pick-up should not exceed dimensions of 6 feet tall, 6 feet wide & 6 feet deep
- Items cannot impede traffic, or block mailboxes, driveways or sidewalks. Items should be at least 3 feet from garbage carts.

Acceptable Items for Pick Up

Large Appliances (doors removed from refrigerators & freezers), Water Heaters, Water Softeners, Toilets, Sinks, Tubs, Mattresses, Box Springs, Couches, Chairs, Tables, Desks, Dressers, Exercise Equipment, Bicycles, Patio Furniture, BBQ's (remove propane tank), Lawnmowers (gas & oil removed), Air Conditioners, Carpets, Rugs, Doors, and Ladders

Unacceptable Items for Pick Up

Tires, TVs, Computer Monitors, Automobile Parts, Household Garbage, Hazardous Waste, Chemicals, Toxic Materials, Liquids, Paints, Solvents, Concrete, Asphalt, Fencing, Construction Debris, Demolition Debris, Wood, Yard Waste, Tree Stumps, Items Associated with Business, Dead Animals, Fluorescent Light Tubes, Sod, Glass, or Mirrors

El programa de Colección acepta artículos voluminosos ya no deseados como calentones de agua, lavamános, escudados. muebles, bicicletas, tinas de baño dos veces por año con cita. No se aceptan monitores de computadoras, computadoras móviles, televisores, vidrio, espejos, tubos de luz, llantas, partes automovilísticas, baterías, basura, desgaste de construcción / demolición (como techo de teja, cercos, y tabla de roca) cemento, ladrillos, asfalto, tierra, rocas, césped, sácate, basura de yarda, artículos asociados con negocios industrial, y desperdicios peligrosos case-ros. Si usted es un residente calificado, llame a su compañía de basura dos semanas antes para hacer una cita. Ponga sus artículos aprobados antes del día de su cita junto en la calle después de las 6 de la tarde. La acumulación de artículos en la calle no puede ser más grande de seis 6' pies de ancho, por 6' pies de largo, y 6' pies de alto. Acumulaciones de artículos no pueden estar mas cerca de 3' pies de los botes de basura. Los artículos no deben impedir tráfico, cajas de correo, banquetas, estacionamientos de carros en la calle en propiedades privadas.
