Media "Pool" Camera / Photography Notice

Modesto, CA - At the request of the family we have established some media rules for the funeral of Deputy Paris. We will have the following set up:

- 1) One pool video and one pool print photographer be allowed in the in the church.
- 2) One pool video and one pool print photographer be allowed at the graveside ceremony.

The media outlets representing this region were allowed to pick the two representatives and they are as follows.

Video/Audio will be provided at both locations by: KCRA Channel 3. The contact number for the KCRA representative is: David Ramos his number is 916-869-4969

Still photography will be provided by: Modesto Bee. Joan Lee is your contact person at 209-404-5434.

****CHURCH MEDIA**** All media live trucks will need to be in place at the church located at 4040 Tully road by 10:00 AM on Friday. We have a designed area for you next to KCRA to the rear of the church. There will be people to direct you to the location. We will also have a designated area at the entrance for reporters and a place during the service to monitor the services.

****CEMETERY MEDIA**** We will need all live trucks in place at the cemetery by 1:00 PM (Lakewood Cemetery in the parking lot to the west of the main office near the monument sign for the cemetery.) We have arranged for KRCA to give you raw footage but no live feed. You can stay until dusk for live shots after the service if you want. We also will take request for Sheriff interviews and hold them after the graveside ceremony if available. There is no designed place for reporters at the Cemetery, just no cell phone photography.

We will have PIO's at the church and cemetery to assist you. The PIO's will have on their left lapel a gold sheriff's star. If you have questions prior about location and other funeral related issues please call Rex Osborn, Lead PIO at 209-456-7297.

The procession route has been established it is: South on Tully road from the church to Briggsmore Ave., Left on Briggsmore to Clause Road. Right on Clause Road to Yosemite Ave. Left on Yosemite Ave. to Sante Fe. Right on Sante Fe to the Cemetery. The route is 11.9 miles long and will interrupt traffic on those streets for an hour or more after the church ceremony. A photo opportunity along the route could include the Fire Department display of the flag that will hang at McHenry / Briggsmore the procession will pass under the flag.
