# Stanislaus County Releases 2014-2015 Recommended Proposed Budget

*Stanislaus County, CA* – The Stanislaus County Chief Executive Office has released the County’s Recommended Proposed Budget for the 2014-2015 budget year. The Budget is a modified “rollover” of the Fiscal Year 2013-2014 budget that will be used as an interim spending plan for Stanislaus County until a Final Budget for 2014-2015 is adopted in September.

The Recommended Proposed Budget for Budget Year 2014-2015 includes \$1,026,518,380 in appropriations and reflects a decrease of \$16,469,351, or 1.6%, when compared to appropriations of \$1,042,987,731 in the Adopted Final Budget for Fiscal Year 2013-2014. The Proposed budget includes \$1,001,035,636 in revenue with \$25,482,744 of one-time funds used for balancing. The proposed General Fund totals \$241,076,432, which is a decrease of 6% from the Adopted Final Budget of \$256,601,294. *(The General Fund decrease is primarily a result of removing Net County Cost Carryover program funds of \$14.8 million for accounting purposes. These same funds then **are added back into the Recommended Final Budget for accounting purposes**).*

“Our goal is to continue to operate in a fiscally conservative way that promotes the long-term health of the County,” stated County Chief Executive Officer Stan Risen. “The rollover budget will allow us to really fine tune our long-term budget strategy as we continue with our goal of striving to be the best county in America.
