## **Losers Unite in Valley Competition** *Weight loss competition kicks off at Health Summit in Newman, California*

Stanislaus County, CA – The end of August signals the start of a regional tradition in Stanislaus and northern Merced counties as the biggest losers prepare to battle.

**The West Side Health Care Task Force is presenting its sixth annual "Healthy Choices Summit" at the West Side Theatre, 1331 Main Street, in downtown Newman, California from 11:30 a.m. - 1 p.m. on Thursday, August 21.**

The Summit will feature the extremely lively "weigh-in" of the local biggest loser contest on a **giant 10 - person scale** under a massive balloon arch. The weigh-in starts at 11:30 a.m. Teams of ten people are battling for the title of "Biggest Loser" in an eight-week weight loss program. Last year, members from Patterson Health & Fitness took the weight loss team title by shedding 120.5 pounds of body weight.

"This contest is a fun way to promote good nutrition and healthy living," stated Jim De Martini, the Stanislaus County Chairman of the Board and Chairman of the West Side Health Care Task Force. "It has become a community tradition and has really moved forward our fight against obesity, diabetes and heart disease."

The health summit will also feature vendor demonstrations, speakers and a free healthy box lunch.

The weigh-out for the Biggest Loser Contest will be held Thursday, October 16, 2014, at Walnut Grove Elementary School in Patterson at 775 N. Hartley Street. The weight-out will begin at 4:30 p.m.

The Westside Healthcare Task Force is a public/private consortium of interested healthcare proponents on the west side of Stanislaus County and northern Merced County including Gustine, Newman, Patterson, and Crows Landing. The mission of the Healthcare Task Force is to foster communication between west side healthcare providers and communities and to identify service gaps and potential opportunities to improve.

The group is facilitated by Stanislaus County Supervisor Jim De Martini (District Five) and meets on a bi-monthly basis rotating between Gustine, Newman, and Patterson.
