## Candidate Deadlines Extend for November Election

Modesto, CA – August 7, 2015 – Stanislaus County Clerk - Recorder - Registrar of Voters Lee Lundrigan announced the regular candidate filing deadline of Fri. Aug. 7 for the Nov. 3 Consolidated District Election has passed. Under California law, filing is now closed except in those 28 races in which one or more incumbents did not file with the county elections official. In those races in which an incumbent did not file for candidacy, the filing period for that race extends five calendar days for non-incumbents to 5 p.m. Wed. Aug. 12. (See attached list.) This information is limited to those races which file directly with the Stanislaus County Elections Official. Candidates for Modesto City Schools Board file with the Modesto City Clerk; candidates for Ceres and Modesto City offices file with their respective city clerks.

As of the regular candidate filing deadline, 17 races have already received a sufficient number of candidates to qualify to appear on the Nov. 3 ballot. It will be determined after the candidate extension closes on Aug. 12 if additional races will qualify.

Following the close of the nomination extension period, the lists of candidates filing with the county elections official and the various city elections officials will be consolidated and finalized for inclusion on the ballot. The *Candidate List* can be viewed on-line at stanvote.com under the *Candidates / Measures* tab on the left-side of the page.

"Candidates interested in filing for these extended races listed below can obtain and file nomination papers at the Registrar of Voters Office located at 1021 "I" Street, Modesto," said Lundrigan. Minimum qualifications required for a candidate to qualify to run for office include Stanislaus County voter registration and residency of the district in which they wish to file. Other requirements may apply. A Stanislaus County resident is entitled to vote in this Consolidated District Election if he or she is a United States citizen, California resident, not in prison or on parole for conviction of a felony and at least 18 years of age on Nov. 3.
