*Stanislaus County, CA* – The month of June signals the start of a regional tradition in Stanislaus and northern Merced counties as the biggest losers prepare to battle.

**The West Side Health Care Task Force is presenting its eleventh annual "Healthy Choices Summit" at the West Side Theatre, 1331 Main Street, in downtown Newman, California from 4:30 – 6:30 p.m. on Monday, June 24, 2019.**

The Summit will feature the extremely lively "weigh-in" of the local biggest loser contest on a **giant scale** under a massive balloon arch. The weigh-in starts at 4:30 p.m. Teams of five to ten people are battling for the title of "Biggest Loser" in an eight-week weight loss program. Last year, members from the City of Newman took the weight loss team title.
