A. CALL TO ORDER & INTRODUCTIONS

- Ron West called the meeting to order. Those in attendance introduced themselves.
- Excused absences were received for Commissioner Judy Loretelli and Brent Bohlender.

B. PUBLIC COMMENTS, STAFF/COMMISSION COMMENTS AND DISCUSSION

- Chair announced the purpose of the Commission's visit to Fairview Park, which is to have a better feel of the Park's current condition. The goal is to bring the Park back to life.
- Manuel Rivera, an employee with Behavioral Health and Recovery Services, Center for Human Services is part of a community service group called Manos Unidos. The Group has been utilizing Fairview Park for their meetings throughout the summer. The Group has contributed their service through working with the Parks Department on community park cleanup events.
- Fairview Park currently has unlevelled grounds, a run-down baseball field, a basketball court, a boarded unusable restroom, tetherball poles, a picnic shelter, and picnic tables throughout.
- Twenty-four community members were present to support Fairview Park. The Group suggested leveling the ground as the first step to improving the park. Leveling the ground will allow for kids to play soccer—one of the popular sports within the area. The current soccer team practices have been cancelled in the

past for the lack of facilities. Commissioner Betty Parker provided an encouragement tip from her experience with the Regional Water Safety Training Center launch efforts in Empire.

- 5. Staff discussed the challenges with sustainability, safety, maintenance, and concerns with declining community commitment over time. The Group is interested in establishing a partnership with the Department on improving the park and is willing to volunteer and assist in any way they can to help. The community believes improvements will bring in more community users where the park will become a safer place. In learning more about the Department’s perspective of sustainability, the community understands that this effort may require an outreach to include organizations such as youths, local schools and businesses.
- 6. Basic needs such as lighting needs and vandalism concerns were briefly discussed. The Commission is in support of the community taking ownership in taking care of the park. The Department will take a further look into the potential costs and the level of service required to maintain the park if the ideal renovations were put into place. The Commission suggested contacts also with the Tuolumne River Regional Park community group through City of Modesto to benchmark on their approach toward sustainability in their facilities.
- 7. A motion was made for the Commission to work with the Manos Unidos community group to create a sustainable plan for Fairview Park. The motion was carried. The Department was asked to provide a cost estimate and overview of the work required for Fairview Park. Commissioners Chad Kennedy and Adrienne Chaney were appointed to meet with the Group to begin a preliminary plan. The Commission plan to send a recommendation to the Board at a later time.

PUBLIC COMMENT - WOODWARD RESERVOIR:

- 8. A question was raised why Woodward Reservoir would close the backside of the reservoir after the Labor Day weekend when the weather was still warm. The suggestion was for the Department to consider keeping the backside of the reservoir open if the weather permits instead of closing it right after Labor Day—an additional two weekends were suggested as a minimum. A complaint was made that the experience of paying \$28 was not worth the trip for the limited area available at such a busy reservoir, and considering the amount of revenue the reservoir receives. The back side of the reservoir is generally closed after Labor Day as seasonal staff are released. Budget concerns for the limited staffing after Labor Day was addressed, and the clarification was made of how the reservoir’s revenue is accounted for. The Department will take into consideration the suggestion received. The Commission asked for this item to be placed on the agenda in November for further discussion.

AB 1234 Ethics Training for Local Officials

On October 7, 2005, the Governor signed Assembly Bill No. 1234. AB 1234 requires that if a local agency provides any type of compensation, salary, or stipend to, or reimburses the expenses of a member of its 'legislative body' (as that term is defined in California Government Code Section 54952), that local agency's officials must receive training in ethics.

The bill also provides that if an entity develops criteria for the ethics training required by AB 1234, then the Fair Political Practices Commission and the Attorney General shall be consulted regarding any proposed course content. **Other than the consultation requirement regarding the training course, the Commission has no jurisdiction to interpret or advise on the requirements of AB 1234.** In response to AB 1234's requirement that the Commission be consulted regarding proposed course content, the Commission has implemented Regulation 18371. Please see Regulation 18371 for information on what the Commission has determined should be included in a local ethics training course. A link to Regulation 18371 and the Attorney General's Office's AB 1234 information can be found below.

There are numerous training options, including training conducted by commercial organizations, nonprofits, or even an agency's own legal counsel. In addition, interested parties have collaborated to create an on-line training program that will allow local officials to satisfy the requirements of AB 1234 on a cost-free basis. The training may be accessed by clicking the button below, and at the end of the training a certification of completion must be printed.

The **free** online training offered here is a self-serve training program. It is your obligation to print a certificate and provide it to your agency in a timely manner. Please allow ample time to ensure that you are able to complete the training by the due date. We are not responsible for unexpected technical difficulties that could occur resulting in unavailability of this training program on our website. No copies can be retained by the program or the website. Please do not share your account.

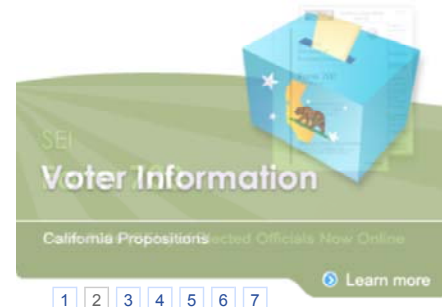
