C. TUOLUMNE RIVER TRUST

- REPORTER Analisa Freitas, West Modesto Organizer of Tuolumne River Trust, presented 1. Analisa Freitas information regarding Tuolumne River Trust (TRT)—"The Voice for the River". TRT is a watershed organization. They have offices stationed in Sonora, Modesto, and San Francisco. The core initiatives of the organization are restoration, education, and advocacy outreach for the riverside and parks. TRT works with the riverside community on improving the environment. A recent project included a collaborative effort of various volunteers and agencies picking up trash along the river from 9th Street to Riverdale Park in the west Modesto region, filling three bins at about 7,000 pounds of trash each. This clean-up event will likely continue again next year. Some concerns were brought up in regards to the lack of restroom available at 2. Riverdale Park. Another concern was addressed with the Riverdale fishing access ramp being too steep. Any improvements to the fishing access may likely involve California Fish and Wildlife. The Commission asked if Riverdale fishing access and other fishing accesses can also be listed in the Capital Improvement Project plans. The Department will consider adding Riverdale Park to the CIP plan.
- The Commission expressed interest in partnering with the Tuolumne River Trust in 3. related projects and grants.

4.	Jami Aggers presented to Adrienne Chaney a certificate of appreciation for her support as a Commissioner on many Parks projects such as the Fairview Park renovation effort and the Frank Raines playground grand-opening.	
F.	OLD BUSINESS	ACTIONS & REPORTER
1.	An update of the CIP plan was provided. Two completed projects were removed from the list—Frank Raines and the Salida area. Two new projects were listed— Bonita Pool and Woodward Reservoir camping areas. Several other projects on the plan were updated with current status information. The CIP proposal will be submitted to the Chief Executive Office as recommended for review; the project priority will be categorized based on available funding.	Merry Rorabaugh
2.	At Fairview Park, a second re-leveling of the grounds was completed. This also includes an ongoing effort of rodent control in the park.	
3.	The Mural Policy was scheduled for review with the Board of Supervisors on April 23 rd , but was pulled off the agenda for concerns on maintenance enforcement, staff time and costs. The Department will await further directions from the Board at a meeting set later in the month.	
4.	A note was made on the maximum occupancy for Empire Pool: 125 for the lap pool and 35 for the kiddy pool. The kiddy play structure may be in need of some repairs soon for rust. The pool will be due for an inspection prior to the summer season's pool opening. A brief discussion was made on lifeguards for pool rentals. The Department will be partnering with PAL for hiring lifeguards for pool rental events. The pool rentals will be handled through the Department's event coordinator and through the exclusive use process. The Commission will be inviting PAL for an overall program update at the next meeting.	
5.	A reminder was given on the special Empire pool fundraiser event on Sunday, June 9 th , 2013. Limited tickets are available and on sale through PAL or Betty Parker.

- 1. The rodent problem at Fairview is pretty much under control. Staff is now trapping when new mounds pop up. They are getting about 3 or 4 per week now as opposed to double digit numbers. We are using castor oil pellets around the perimeter of the park to keep gophers & squirrels from coming in. It seems to be working. We believe the gophers being trapped are some that were not eliminated prior to the pellets being utilized. Staff has been using a drag screen pulled behind a tractor to continue leveling out the area. Once we are able to reseed, it should be a much nicer area. The increased labor in this park is causing staff to fall behind in their other Parks and we hope that we will be able to shift our focus away from Fairview soon before complaints start coming in from other areas.
- 2. Riverdale Park continues to be hit with vandalism. Recently the backflow for the drinking fountain was damaged in an attempt to steal it. As a result, the drinking fountain has been turned off and the backflow removed to deter the vandals from coming back and stealing it. We have talked to members of the community and made them aware that most of this is happening in broad daylight. We have encouraged them to keep their eyes open and report any unusual activity in the park.
- 3. One of our concrete picnic tables at Oregon Park was vandalized and broken. There is a 10 year warranty against vandalism on the tables and we are getting a replacement for free.
- 4. The Empire Pool opened for the season on June 1, 2013. PAL gave us their schedule and they plan to operate through August 2, 2013. They are open Tuesday through Sunday. Monday's are closed for maintenance. They are open from 12:30 p.m. to 5:30 p.m. each day with two swim sessions per day.
- Notified on June 4th, La Grange received \$91,517.00 and Frank Raines received \$225,794 for a total of \$317,311.00. We were in the top 17 agencies who received money for Operations and Maintenance; there were 79 requests. The State had 5 million to offer, and there were 16 million in requests.
- 6. In partnership with the Department of Boating and Waterways and Sheriffs STARS volunteers, a new Life Jacket Loaner Pilot Program was implemented at Woodward Reservoir. Jackets include adult, youth, and infant sizes; a total of 75 life jackets all together were donated for the program. As of date, the program have been successful with one forgotten return. The borrower however called immediately and returned it soon after.
- 7. Received the Recycling Grant monies for purchase of 2 Message Boards for Laird Park. One message board will hold the Volunteer Thank You sign and the other sign will be utilized for messages regarding rental of the facility. Cost was approximately \$2,100.00.
- 8. Additional tables were purchased for Frank Raines day use playground area. This included adding grass and irrigation around the playground. PFF monies were used for this project. Frank Raines Regional Park is also getting a new park flag. (See example attached.) There is already a flag pole on site.
- 9. Completed the San Joaquin Valley Lawn Garden Program Received \$9,993.90 in equipment for free. One self-propelled mower, 2 hand held blowers, 1 chain saw, and 3 trimmers.
