- 2. The OHV season is open at Frank Raines. Stanislaus State University rented the Empire pool for six weeks while their pool underwent construction.
- 3. The Department assisted the community group, Manos Unidos in writing and submitting a research grant for an exercise playground out at Fairview Park. The group is looking into major sponsors and upcoming fundraising events to match the grant funds at half. Matching funds must be met by March 1st. The grant is an all or nothing grant. Due to the short deadline, the group is hoping for a later extension as they work on finding the matching funds. Briefly, Betty shared the Empire pool's fundraising experiences. The Empire pool project also received a State grant with fund match contributions. Recommendations were made for Manos Unidos to find several fund matching sponsors.
- 4. The Department's marketing plan is still in the works. Current progress includes working with Bass Pro to bring out a couple of events to County facilities. An update can be provided at the next meeting. Concession options are being looked into by the Chief Executive Office.







RE: Concepts for community and commercial engagement of Stanislaus County assets

I have reviewed some of the assets that the County owns and I have some thoughts about the recreational opportunities that could be created.

My understanding of the situation is that the County does not have a great deal of money to expend in the area of development. With that in mind I would be really relying on public/private partnerships. What I mean by that is that the private sector will put up the labor and more or less execute the event. The County's responsibility will be to allow the use of the property for the project and perhaps even lend money to kick start a worthy project.

The projects that I am going to suggest will be both site specific and for general locations.

Some of the projects will simply be considered "fun projects" that simply catch the interest of the community while others will enjoy almost and industrial execution.

All projects will be considered "renewable". That means that if enjoyed and considered worth while after experiencing the event, they can be repeated each and every year on a renewing basis.

I would like to see the community eventually sponsoring one event each month.

Each project will be a financially stand alone event.

Gun Range:

We have plenty of property that would be well suited for a really good gun range. Clark County in Las Vegas has a major gun range which hosts major events. It literally brings in millions of dollars to the community each and every year. I am aware that there is private interest and perhaps funding for this project. This is a 12 month a year proposition. It would be reasonable to have at least one national or international major shooting event a year sponsored by the range. With 1000 people it would not be

unreasonable to state that this would provide a \$300,000+ cash injection to the County from both gate and entrance fees as well as concessions and lodging etc. the first year.

The Park Chili Cookoff and Music Festival:

The format for this event is very simple. A park is selected. Several bands are recruited. This is fundamentally a Chili Cookoff. Businesses and restaurants as well as individuals vie to the best chili. It will cost the vendors \$100 to \$200 to have a booth. You have some celebrity judges who are "official tasters". This is really a hooky event that can really have legs. It could easily grow over the years. for an ultimate impact look no further than the Stockton Asparagus Festive. the first year I would think that the event would earn some money but it would primary be a fun event. Sponsors will hawk the tickets and pay a fee. Visitors will pay an entrance feel. I would think that the first year's revenue would be a net \$25,000 to \$50,000.

BBQ and Blues

There is almost nothing better than to hear good Blues Music and eat BBQ. Anyone of our developed parks could be the ideal setting. This kind of event is fun and it can be profitable. Like Davenport, Iowa there is a BBQ contest for the best BBQ and the vendors will strive for "bragging rights". It does require organization but it can be a real deal for the community and the Rec. Dept. This would need to be a partnership program.

The above ideas are just suggestions. Many will require partnerships. One can use either commercial vendors or we could use community organizations which would jump at some of the programs.

Music and Art Fair

Around Oct. or Nov. we should have an Art and Music Fair. Entrance if fee. the artist (Juried) will pay a fee and a percentage of their gross to participate. Properly managed this could be a bid deal. Successful event earn literally \$100,000 net plus each and every year for the promoters.

Crows Landing International Drone Conference

There is nothing like this in the world. This would be an international venue. It focuses on hobbiest, commercial and military drones. The airport is absolutely perfect for the event. The event will require real players to be involved but they will do the deal once they see the value of the demonstrations and conference. This will put Stanislaus County on the map for the emerging tech. industry. I would hope to break even the first year and if successful it could represent many future jobs and lots of money to the community.

The Modesto Reservoir or the Woodward Reservoir Long Distance Swim.

This event focuses on our in place resources. We would offer a group of contest for distant swimming. We could have youth (grade school) high school, college recreational non-competitors and elite. this is a professional and world class group. This would be a late spring event.

Properly managed with sponsorship we could earn \$50,000 to \$100,000 the first year. Imagine 250 high school teams competing. I did an event similar to this in Ceres and it was seen by 13 million people on ESPN. There are all kinds of opportunities to earn money in this kind of event.

Horses

There is a real opportunity to have an horse event. People love horses. How about a long distant horse race or an organized saddle ride?

Winter Play

You know there is nothing better than a pie, cookie and cake contest. This could be held at virtually any of our facilities but it works best indoors. Make it open to the public. Have a fee to enter and of course someone or an organization will earn bragging rights for the best goodies. This probably will not be a huge fundraiser but it should cash flow from day one and it should be really fun. (I want to be a judge).

Motorcycle Race

We have one of the best potential sites for an international event in East Stanislaus County. With management this could be a huge cash infusion to the county plus real recognition. Dirt bike racing is big business. This should be a money event. With good marketing this could easily be a "cash cow" for the community.

Guns and Shooting

Las Vegas has a huge gun range. It brings in many millions of dollars each year. I don't expect Stanislaus County to develop such a program but we could easily develop a more modest approach. In this country guns are big business. We have plenty of areas in which to develop a commercial gun range. People would flock to it. Shooting contests are big business. Due to our proximity to millions of people it would be reasonable develop and annual event that was special and very profitable.

Summary

Ideally Parks and Rec. would have a dedicated organizer to keep the events on track. Yes, this would be a budget item but the events would pay the cost. Money would have to be fronted.

There are four aspects to the above ideas;

- 1. The individual events should be designed to be profitable.
- 2. The events should be really fun.
- 3. The events should engage the public not-for-profits, clubs or commercial partners.
- 4. The Count will have to front some money. Like the Woodward Res. fireworks event, the County loaned Parks and Rec. \$10,000 to start the program and we paid the money back in full shortly there after.

I hope that the above gives you an idea of what we could do. It will require some organization but once the basic organizational format is established it is sort of "cookie cutter".
