Α.	CALL TO ORDER & INTRODUCTIONS	Actions
	The meeting was called to order and those in attendance were noted. Joseph Sanchez attempted to join the meeting via telephone conference but was unable to connect during the meeting due to technical issues.	Zachary Keller

D.	APPROVAL OF MINUTES	Actions
	Minutes for the November 10, 2016 meeting were approved upon motion and second as written. There was no meeting in December and January.	West, Plaugher-Macias unanimous approval
E.	STAFF HIGHLIGHTS	ACTIONS & REPORTER
1.	Weather conditions caused several trees to fall down at the reservoirs. The winter season generally consist of maintenance and repairs. A question was raised whether the tree removal process is recycled for other uses such as brush piles for wildlife habitat. Fallen trees are mainly used for firewood.	Merry Mayhew
2.	The Department has seen an increased number of reservations both online and walk-in. The past quarter results showed an increase in visits of 300% from last year's visitation data, however, the new tabulation system may be a factor to be considered on how it affects statistics. Visitation was recorded at 8,500 visitors last year to this year's 32,000 for the same quarter.	
3.	State Fish and Wildlife planted trout at both reservoirs in November. About 1,400 pounds of fish were planted. The State website has more information on fish plants and its location.	
4.	La Grange Regional Park is being monitored for erosion control and fencing projects. The Park has been popular with mudfest events. The revenue generated is usually around \$5,000 per event. Vandalism and trespassing issues are being addressed with neighboring properties to the OHV park.	
5.	A vehicle access restriction has been placed out at Riverdale Park. The three trees removed at Empire Park have been replaced with crepe myrtle trees. The proposal to fund repairs of the Empire pool has been submitted with anticipated completion prior to the pool's re-opening.

- 6. Broadway Park restrooms are scheduled for repair once the rain stops. The Salida MAC voted to convert the volleyball court into a horse shoe pit.
- 7. Plans for Fairview Park are still in progress. Since the playground installation, there has been limited graffiti and vandalism due to supporting efforts of community watch. The public community meeting went well. Ms. Plaugher-Macias commented that the meeting was a model for community engagement and gave a job well-done to Cathy Gomez, Joseph Sanchez, and Manos Unidos for successfully organizing the Fairview Park project.
- 8. A section of the Frank Raines OHV Park has been closed due to the floods. Sections of Laird park is also under water, along with many areas throughout Stanislaus County.
- 9. O'Dell Engineering has been informed of the intent to award the Parks Master Plan Project. The Department is looking forward to working with O'Dell Engineering. The award process is expected to be finalized near March.
- 10. The Department is working with Counsel on the gun range clean-up project currently in regards to CEQA regulations. Clean-up cost will be coming out of the County budget.
- 11. The unsuccessful Modesto Reservoir fuel pump bid project is being redesigned with assistance from Public Works.
- 12. The dog ordinance change agenda item has been approved by the Board on December 13th and confirmed to take effect thirty days thereafter.
- 13. The Department is looking into creating an event venue on the north side of Woodward Reservoir. A CEQA process will be initiated this year. Phase one will have fencing and road improvements. The project description to CEQA will keep future planning open to various types of use. The group discussed partnerships and foundations relative to area development contributions. Program sponsorship can be an option to explore.
- 14. A public meeting will be held on February 15th for the OHV grant meeting.
- 15. The Department has hired on a new marketing coordinator as of January 30th, and this person will be working on coordinating all the major events i.e. boat/sports expo at Woodward Reservoir, Easter egg hunt at Modesto Reservoir, and the annual fireworks celebration. The fireworks show this year will be held on July 1st. A question was raised why guns and hunting equipment would be excluded from the sports expo. The Department will be looking at County ordinances in regards to firearm restrictions and its limitation at the sports expo. Advertising includes billboards, social media, radio advertising, live radio hosting, public and sponsors advertising.

F. OLD BUSINESS ACTIONS & REPORTER 1. The plaque for Empire pool has been received and will be installed onsite once it is presented at the Board meeting on February 28th.
