

## HIRING RETIRED STANCERA SAFETY MEMBER

California Public Employees' Pension Reform Act (PEPRA) and IRS requirements both have regulations that govern the hiring of extra-help retirees when they have retired from the employer's retirement system. In order to assure compliance with the regulations Stanislaus County has developed procedures to confirm employment eligibility for any retired StanCERA member prior to the retiree returning to work in an extra-help capacity. The table below outlines the requirements:

**Note 1:** If a StanCERA Retiree who has received unemployment insurance from post-retirement employment with a StanCERA employer, is hired prior to meeting the 12 months waiting period for unemployment insurance they must be terminated on the last day of the current pay period.
