PLN2014-0111 6-X DAIRY</u> *Requesting continuance to September 3, 2015 -* Request to add 1,015 milk/dry cows to an existing herd count of 1,265 for a total of 2,280 mature cows on an existing 397± acre dairy facility. The property is located at 9848 Milnes Road, east of Albers Road, west of Oakdale-Waterford Highway, north of Dusty Lane, in the Waterford area. The Planning Commission will consider adoption of a CEQA Negative Declaration for this project. - *B. VESTING TENTATIVE PARCEL MAP APPLICATION PLN2014-0030 CHRISTIANSEN TRUST- Requesting indefinite continuance. Request to divide a 68,825+/- square foot parcel into a 22,000 square foot parcel and a 46,825+/- square foot remainder in the R-A (Rural Residential) zoning district. The property is generally located on the east side of Grimes Avenue, north of Paradise Road at 1825 Moesher Avenue, in the Modesto area. This project is considered Exempt from the California Environmental Quality Act. APN: 017-030-029 Staff Report: Miguel Galvez, Senior Planner, Recommends INDEFINITE CONTINUANCE.
