A. USE PERMIT AND DEVELOPMENT AGREEMENT APPLICATION NO. PLN2020-0010 – STANCO FAMILY FARMS – Requesting an indefinite continuance - Request to operate a commercial cannabis cultivation, nursery, and distribution business on a 35.8-acre parcel in the General Agriculture (A-2-40) zoning district. The project proposes to construct eight, 3,920 square foot greenhouses and one 1,500 square-foot warehouse for processing activities. A Development Agreement is included in the project request. The project is located on Sullivan Road, abutting the California Aqueduct to the east, and the County of Merced to the south, in the Newman area. The Planning Commission will consider a CEQA Mitigated Negative Declaration. APN: 028-015-026. [View Item]
