### **STANISLAUS COUNTY REQUIREMENTS TO SELL PISTOLS, REVOLVERS, AND OTHER FIREARMS CAPABLE OF BEING CONCEALED UPON A PERSON**

#### **NEW LICENSE REQUIREMENTS**

1. Good moral character. Does not have an arrest record which would show a propensity to engage in conduct of a violent nature or tends to create a history of enforcement problems.
2. Must have a current Federal Firearms License.
3. Must be a resident of Stanislaus County or have a permanent business in Stanislaus County.

#### **RENEWALS**

License to Sell Pistols, Revolvers, and Other Firearms Capable of Being Concealed Upon A Person will expire 1 year from the day issued. The licensee may request renewal of the license by submitting the Stanislaus County application form and a copy of the applicant's current Federal Firearms License. The application will be forwarded to the after the Stanislaus County Sheriff's Office Investigative Division for review and approval/denial.

#### **COST**

1. New License: Issued for 1 year at a cost of \$29.00 per order of the Stanislaus County Board of Supervisors on July 1, 1975.
2. Renewal of License: For 1 year at a cost of \$29.00 per order of the Stanislaus County Board of Supervisors on July 1, 1975. Failure to renew by the renewal date will result in a \$10.00 penalty for late renewal.

#### **LICENSE REVOCATION**

1. Arrest for a crime of a violent nature.
2. Conviction of a Felony.
3. Creates a history of enforcement problems after obtaining a license.

#### **CALIFORNIA PENAL CODE**

##### **26500**

California Penal Code 26500 (a) and (b) provides, in relevant part, that "No person shall sell, lease, or transfer firearms unless the person has been issued a license pursuant to Article 1 (commencing with Section 26700) and Article 2 (commencing with Section 26800) of Chapter 2." Any person violating this section is guilty of a misdemeanor.

##### **26705**

- (a) The duly constituted licensing authority of a city, county, or a city and county shall accept applications for, and may grant licenses permitting, licensees to sell firearms at retail within the city, county, or city and county. The duly constituted licensing authority shall inform applicants who are denied licenses of the reasons for the denial in writing.
- (b) No license shall be granted to any applicant who fails to provide a copy of the applicant's valid federal firearms license, valid seller's permit issued by the State Board of Equalization, and the certificate of eligibility described in Section 26710.

## **CALIFORNIA PENAL CODE continued**

- (c) A license granted by the duly constituted licensing authority of any city, county, or city and county, shall be valid for not more than one year from the date of issuance and shall be in one of the following forms:
  - (1) In the form prescribed by the Attorney General.
  - (2) A regulatory or business license that states on its face "Valid for Retail Sales of Firearms" and is endorsed by the signature of the issuing authority.
  - (3) A letter from the duly constituted licensing authority having primary jurisdiction for the applicant's intended business location stating that the jurisdiction does not require any form of regulatory or business license or does not otherwise restrict or regulate the sale of firearms.
- (d) Local licensing authorities may assess fees to recover their full costs of processing applications for licenses.

### **26810**

A person's license under this chapter, or a copy thereof certified by the issuing authority, shall be displayed on the premises where it can easily be seen.

### **26815**

No firearm shall be delivered:

- (a) Within 10 days of the application to purchase, or, after notice by the department pursuant to Section 28220, within 10 days of the submission to the department of any correction to the application, or within 10 days of the submission to the department of any fee required pursuant to Section 28225, whichever is later.
- (b) Unless unloaded and securely wrapped or unloaded and in a locked container.
- (c) Unless the purchaser, transferee, or person being loaned the firearm presents clear evidence of the person's identity and age to the dealer.
- (d) Whenever the dealer is notified by the Department of Justice that the person is prohibited by state or federal law from processing, owning, purchasing, or receiving a firearm. The dealer shall make available to the person in the prohibited class a prohibited notice and transfer form, provided by the department, stating that the person is prohibited from owning or possessing a firearm, and that the person may obtain from the department the reason for the prohibition.

### **26820**

No handgun or imitation handgun, or placard advertising the sale or other transfer thereof, shall be displayed in any part of the premises where it can readily be seen from the outside.

### **26825**

A licensee shall agree to and shall act properly and promptly in processing firearms transactions pursuant to Chapter 5 (commencing with Section 28050).

### **27505**

- (a) No person, corporation, or firm shall sell, loan, or transfer a firearm to a minor, nor sell a handgun to an individual under 21 years of age.

### **28110**

- (a) The State Printer upon issuing a register shall forward to the Department of Justice both of the following:
  - (1) The name and business address of the dealer.
  - (2) The series and sheet numbers of the register.
- (b) The register shall not be transferable.
- (c) If the dealer moves the business to a different location, the dealer shall notify the department (Stanislaus County Treasurer-Tax Collector's Office) of that fact in writing within 48 hours.

**EXPORTATION OF ARMS AND AMMUNITION:**

It is a violation of United States Law (Title 22, United States Code, Section 2778) to export arms and ammunition from the United States to any foreign country without a license issued by the Department of State. Violation of this section may subject the violator to criminal prosecution. Additionally, the conveyance used to transport arms or ammunitions in violation of law is subject to seizure under the provisions of Title 22, United States Code, Section 401.

**TRANSLATION**

Es una violación de la ley de Los Estados Unidos (Título 22, Código de Los Estados Unidos, Sección 2778) exportar armas & munición desde Los Estados Unidos a cualquier país extranjero sin haber obtenido una licencia expedida por el Departamento de Estado. Violación de esta sección someterá al sujeto violador de la misma a juicio criminal. Además, el vehículo utilizado para el transporte de armas o munición en violación de la ley está sujeto a decomisarian bajo los reglamentos del Título 22, Del Código de Los Estados Unidos, Sección 401.
