<u>BEHAVORIAL HEALTH INFORMATION NOTICE (BHIN) 25-029 Assembly Bill (AB) 2473 Alcohol or Other Drug (AOD) Counselor Educational Requirements</u>

BHIN 25-029 published July 31, 2025, outlines DHCS' updated educational requirements for Alcohol or Other Drug (AOD) Counselors under AB 2473. Effective January 1st, 2026, new registrants must complete minimum hours of training in core competencies within the first six months of registration. NEW Medi-Cal Certification Email Inbox

Reminder to All Medi-Cal Certified Programs

Any program with a Medi-Cal Certification must IMMEDIATELY notify their System of Care Chief and Quality Services (QS) of any changes to their facility that may impact the Medi-Cal certification, including permanent or temporary closures, name change, location moves, structural modifications, changes in mode of services, updates to Head of Service or Program Director, etc. Failure to report such changes may adversely impact the Medi-Cal Certification – impacting billing and compliance with DHCS. As soon as we are notified of any type of change by your agency, Quality Services will inform DHCS and submit necessary documentation to ensure the site certification remains in good standing. BHRS IT UPDATES

Use of County Issued Devices for all County & BHRS Related Work
