VI.B Stanislaus County Auditor-Controller report regarding Administrative Budgets:

The Auditor-Controller reviewed Health & Safety Code §34179J that established County Oversight Boards to oversee Successor Agencies and approve redevelopment wind-down obligations. He also discussed the roles and

responsibilities of the County Auditor-Controller, Successor Agencies, and Department of Finance.

Pursuant to SB 107, Section 34171, the administrative cost allowance is \$250,000, but cannot exceed fifty percent of the agency's Redevelopment Property Tax Trust Fund (RPTTF) amount in any fiscal year.

A reconciliation of estimated versus actual costs will be submitted to the County Auditor-Controller for review and the difference will result in adjustments to the amount of property tax distributed by the County Auditor-Controller to the Successor Agency's Redevelopment Property Tax Trust Fund.

It is recommended the Countywide Successor Agency Oversight Board of Stanislaus County review and approve the Successor Agencies' Proposed Administrative Budgets and the accompanying draft Administrative Budget Resolutions.
