#### **BHRS All Staff Meeting**

### PERFORMANCE IMPROVEMENT PROJECT (PIP) COMMITTEE UPDATES

#### **PIP Topic Selection and EQR Submission**

Under federal Medicaid regulations (42 CFR § 438.330) and California Department of Health Care Services (DHCS) mandate, counties must implement at least two PIPs – one clinical and one non-clinical – to improve the quality, access, or outcomes of services provided to members. These PIPs are reviewed ongoingly as part of the External Quality Review (EQR) by Health Services Advisory Group (HSAG). As of January 2025, Stanislaus County BHRS has selected the following PIP topics for the PIP period 2025-2027 and will submit its PIP baseline documentation to HSAG on July 14<sup>th</sup>, 2025, for the first EQR submission:

- Clinical PIP: Improve the rate for the measure, Pharmacotherapy for Opioid Use Disorder (POD)
- Non-Clinical PIP: Increase the percentage of members who receive at least one Peer Support Service

### MEDICAL RECORDS (MR) UPDATES

#### **Reproductive Health Member Designation in EHR**

Staff are advised to review new guidance on properly categorizing members with reproductive health information in SmartCare. Many members currently fall under general data sharing settings, which do not provide adequate privacy protections for this sensitive information. A special population classification must be added in the EHR for affected members. This update is essential for ensuring the privacy and security of member information and compliance with relevant policies and regulations. Be sure to carefully review the updated process outlined in the attachment to ensure you are following the appropriate procedures.

### UTILIZATION MANAGEMENT (UM) UPDATES

#### **Effective Immediately: Updated Email for Health Net Screening and Transition Tool Submissions**

Please be advised that Health Net has updated its contact email address for submitting Screening and Transition of Care Tools, effective immediately. The updated process is available for review on the intra/extranet. Please refer to the email sent by UM on May 23, 2025, for full details. Be sure to carefully review the updated process outlined in the attachment to ensure you are using the most current information.
