PRESENTATION: RAIZ PROMOTORAS

Janet Nunez-Pineda, Ed.D., presented on the RAIZ Promotoras, community behavioral health outreach workers. A promoter plays a critical role in promoting prevention focused and community-based behavioral health education and activities, particularly in communities historically underserved targeting the Latino/Spanish speaking community. The Promotoras engage residents, including children, youth adults and older adults by utilizing the following prevention strategies: outreach, engagement, access and linkage. Kevin Panyanouvong, BHRS Chief Operations Officer, reported:

• BHRS has partnered with Modesto Police Department, the Sherriff's Office and has now contracted with Emergency Medical Technicians (EMT) to have clinicians ride along and respond to mental health crises.

- Four Behavioral Health Specialists positions have been filled. Two clinicians had been hired; one clinician has since left.
- BHRS is currently in process of hiring two part-time Peer Support Specialists.

Tony Vartan, BHRS Director, reported the following highlights:

- BHRS now has a Post Hospitalization Clinic that provides follow-up appointments within a week for consumers being discharged from hospitals. The second use for the clinic will allow those in crisis to walk into the clinic to see a psychiatrist or have an appointment expedited.
- BHRS will continue to build substance us disorder (SUD) equity of services.
