PRESENTATION: Community Assistance, Recovery, and Empowerment (CARE Court)

Tony Vartan, BHRS Director, provided a PowerPoint presentation with a brief overview of Community Assistance, Recovery, and Empowerment (CARE Court). CARE Court is a new civil court process designed to connect individuals with certain mental health diagnosis over a one-to-two-year process with county behavioral health services under the oversight of a judge. The Board of Supervisors approved the implementation and the request for additional staffing on April 18, 2023, <u>see agenda item 7.2.</u> Chandra Campbell was introduced as the CARE Court Manager.
