Natalie Legorreta, BHRS Substance Use Disorder (SUD) Education and Prevention, presented on the dangers of fentanyl and its effects in Stanislaus County. PUBLIC COMMENTS: GENERAL, CONSUMER, FAMILY

Jennifer Williams, member of the Families Advocating for the Seriously Mentally III (FASMI), addressed a letter to the board stating her daughter's recent passing and the struggles experienced due to her illness.

Steven Cullen, LGBTQ Collaborative, stated there is a lapse in care with patients discharged from Doctors Medical Center (DMC) emergency room. Patients are discharged with only three days' worth of medication which is not enough medication as appointments for mental health are not available during that timeframe. Steven expressed the lapse in care leads to consumer decompensation.

A guest shared she received fourteen days of medication after DMC discharge. She was unable to refill the medications and felt that it was impossible to stabilize as she was also struggling with substance use disorder.

COMMITTEE REPORTS

Executive Committee

Charmaine Monte reported the committee reviewed the agenda for November. Kevin Panyanouvong shared with the committee that BHRS continues to work with Stanislaus State University to onboard clinical staff interns. BHRS is hoping to also work with UC Merced in the future.

Margie Johnson reported they received a presentation the Behavioral Health Wellness Center.

Substance Use Disorder (SUD) Committee

Annie Henrich reported the committee received a presentation from the Stanislaus Recovery Center.

DEPARTMENT REPORT

Tony Vartan, BHRS Director, reported the following highlights:

- BHRS will be working to expand SUD services and reduce wait time for an assessment.
- BHRS will have a post-hospitalization clinic to prevent a lapse in treatment.
- New legislations:
 - AB2275: This critical bill strengthens safeguards for people who are involuntarily detained for mental health treatment under California's Lanterman-Petris-Short (LPS) Act. This bill will address inconsistent interpretations of the LPS Act by counties across the state by making two important changes to the law by creating uniform standards for procedures that counties must follow to ensure that involuntarily detained people have timely access to due process.
 - AB2242: LPS MHSA funding and Care Coordination funding, this bill would require a care coordination plan to be developed and provided to an individual before being discharged from a hold or released after being detained for evaluation and treatment. The bill also states a person cannot be denied any MHSA services if they are in an involuntary or voluntary hold.
 - SB929: requires DHCS to collect and publish data from hospitals that accept 51/50 individuals in order to look at timelines for length of hold and treatment. The state will use the data for outcome measures.
 - SB1338: CARE Act, Stanislaus County is one of seven counties implementing CARE Act by October 2023.
 - AB988: "9-8-8" emergency response system for Californians experiencing a mental health crisis is still in process.
 - AB2473: Will require DHCS to regulate core competencies for SUD counselors.

ANNOUNCEMENTS

Kathy Rupe shared there will be a Drop the Drugs Event on October 29, 2022, 10:00 a.m. – 2:00 p.m., at the Stanislaus County Superior Court House, 800 11th Street, Modesto and at the Turlock Police Department, 244 N. Broadway.

Annie Henrich, Stanislaus Asian American Community Resource (SAACR) member, shared that SAACR will have a vaccine clinic on October 29, 2022, at the Asian Market, 2425 McHenry Ave, Modesto, from 9:00 a.m. – 3:00 p.m.

Charmaine Monte shared that the week of October 24, 2022, is Red Ribbon Week, a national celebration and awareness campaign of all the dangers of using controlled substances and encouraging students to have healthy relationships and behaviors.
