PRESENTATION: Proposition 1: Behavioral Health Infrastructure Bond Act of 2024 Project Application

Leonor Sierra, BHRS Chief, Integrated Services and Maribel McCarroll, Behavioral Health Services Act (BHSA) Policy Manager provided a PowerPoint presentation on Proposition 1, Behavioral Health Infrastructure Bond Act of 2024 Project Application, a two-bill package to modernize the state's behavioral health care system, improve accountability, increase transparency, and expand the capacity of behavioral health care facilities. A copy of the PowerPoint presentation was distributed to the board members.

DEPARTMENT REPORT

Tony Vartan, BHRS Director, thanked SRC staff for hosting BHB meeting and emphasized the value of supporting and encouraging one another through recovery.

The following highlights were reported:

- SB43 is on schedule to be implemented on January 1, 2025.
- The first CARE Court graduation will take place on December 9, 2024, at 10:00 a.m., at the Board of Supervisors' chambers, located at 1010 Tenth St. Modesto.
- CARE Act data was reported.
- Housing projects continue to expand in Stanislaus County:
 - Turlock facility holds 87 beds and is ready to receive clients.
 - Transitional housing with 42 units at the corner of 9th St. and L St. in Modesto.
 - Housing for Behavioral Health and Substance Use Disorder population.
- BHRS continues to work on new projects and initiatives to increase funding for crisis and expand services.
- BHRS submitted an application to the State, for funding of twelve million for infrastructure and twelve million for supplemental care, for individuals that maybe incompetent to stand trial.

- The 24/7 Mobile Crisis Unit contracted with Telecare is completely operational to assess individuals throughout the entire county.
- Veterans' symposium was held on November 9, 2024, in Patterson, CA focusing on the importance of integrating services for Veterans.
- Integrated Care Center project for SUD individuals regardless of coverage can be assessed and receive service.
