Age breakdown is as follows:</p> <ul style="list-style-type: none"> • 0-5: 3.56% or 359 individuals • 6-17: 30.97% or 3,127 individuals • 18-24: 9.67% or 976 individuals • 25-34: 17.93% or 1,810 individuals • 35-44: 15.70% or 1,585 individuals • 45-64: 19.30% or 1,949 individuals • 65-75: 2.58% or 261 individuals • 76+: 0.30% or 30 individuals <p>Lezzette has completed interpreter training and is now able to offer three yearly training courses through our training department to linguistic staff. Lezzette also reviewed some cultural training currently offered at BHRS.</p>
